THE HOSPITAL PROVIDED CHARITY CARE TO 794 PATIENTS AT REDUCED OR NO-CHARGE FOR SERVICES FURNISHED UNDER THE HOSPITAL'S COMMUNITY CARE POLICY AGGREGATING \$936,582. THE COST OF THESE SERVICES WAS \$525,423.
